NO. E&A(Health)/3-68/2017 (SBT): In exercise of the powers conferred by section 30 of the Khyber Pakhtunkhwa Blood Transfusion Safety Authority Act, 2016 (Act No. XXV of 2016), the Khyber Pakhtunkhwa Blood Transfusion Authority is pleased to make the following regulations, namely:

THE KHYBER PAKHTUNKHWA BLOOD TRANSFUSION AUTHORITY (APPOINTMENT AND REMOVAL OF CHIEF EXECUTIVE OFFICER) REGULATIONS, 2017

- 1. Short title and commencement.---(1), These regulations may be called the Khyber Pakhtunkhwa Blood Transfusion Authority (Appointment and Removal of Chief Executive Officer) Regulations, 2017.
 - (2) These shall come into force at once.
- 2. **Definitions.---**(1) In these regulations, unless the text or context otherwise requires, "Act" means the Khyber Pakhtunkhwa Blood Transfusion Safety Authority Act, 2016 (Act No. XXV of 2016).
- (2) The words and expressions used but not defined in these regulations shall have the meanings as assigned to them under the Act or KP Blood Transfusion Safety Regulations, 2017.
- 3. Appointment of Chief Executive Officer.---(1) In terms of section 9 of the Act, the Chief Executive Officer shall be appointed by the Authority on the recommendations of the Scrutiny & Selection Committee to be constituted by the Authority under section 8 of the Act.
- (2) The term of Chief Executive Officer shall be three years which may further be extended for another term.
- (3) The post of Chief Executive Officer shall be advertised by the Authority in at least two newspapers of vide circulation (one in English and one in Urdu).
- (4) The Scrutiny & Selection Committee shall scrutinize the documents and credentials of the all the candidates, interview them and recommend three (03) names to the Authority for the appointment of one of them as Chief Executive Officer.

Provided that till the appointment of a Chief Executive Officer or in situation where Chief Executive Officer position falls vacant as a result of resignation, termination or any other reason, the Authority may appoint officiating Chief Executive Officer or requisition services of a suitable officer from Health Department for an interim, maximum, period of six months, as the Chief Executive Officer.

- Salary package.---The Chief Executive Officer shall be entitled to market based salary package as approved by the Authority.
- 5. Other terms and conditions.---The Chief Executive Officer -
 - (a) shall possess a recognized Master Degree in Public Health or Health Services Management or Business Management or equivalent qualification with at least ten (10) years' relevant experience of managing an organization in public or private sector;
 - (b) shall be a bonafide resident of the Province of the Khyber Pakhtunkhwa;
 - (c) has not been convicted by any Court of law for moral, civil or criminal turpitude; and
 - (d) has no conflict of interest with such position.
- Removal of Chief Executive Officer.---(1) Wherein opinion of the Authority, Chief Executive Officer is-
 - (a) inefficient, or has ceased to be efficient for any reason;
 - (b) guilty of misconduct; or
 - earned reputation of being corrupt or reasonably be considered as engaged corrupt; or
 - (d) engaged, or is reasonably be considered as engaged in activities considered to be in conflict of services and KP Blood Transfusion Authority-

the Authority shall after inquiry by a Committee of the Authority, by order in writing remove or terminate services of the Chief Executive Officer.

- (2) Before passing an order of termination, the Authority shall in writing inform the Chief Executive Officer of the action proposed to be taken with regard to him and the grounds of the action and give him a reasonable opportunity of showing cause against the action within seven (07) days or within such extended period as the Authority may determine.
- (3) Special meeting of the Authority shall be convened for the purpose whereby considering the recommendations of the inquiry committee and examining the response of the Chief Executive Officer, and decision shall be taken with majority of the vote.
