Terms and Conditions:

- 1. The appointment is purely on Fixed Pay Package (Non-transferable).
- 2. The appointment is purely on contract basis which can be terminated at any time without assigning any reason as per project policy.
- The appointees shall produce Medical Fitness Certificate from the office of the Medical Superintendents of DHQ Hospital.
- Salaries will be released after verification of all the documents and fulfillment of other formalities.
- 5. If the appointee wishes to resign from the service, prior notice of 30 days should be submitted otherwise salary of 30 days have to be deposited in lieu thereof.
- 6. The employee are entitled of two days casual leave on full pay per month on duty rendered.
- The employee shall not be entitled to undergo any kind of training inside country or abroad.
- The employees shall not indulge in any trade, business and any other activity what so ever, which has been declared prohibited under Civil Servant Act 1973.
- In case the employee is found undergoing training in any institution sponsored by any Health Project of the Government or Private sector either Provincial or Federal, his/her contract will be terminated instantly.
- 10. The concerned DHO shall be personally responsible for verification of documents/certificates/degrees of the appointees from the relevant forum and his/her salary shall not be released till the verification of the documents.
- 11. They will serve in any district assigned to them by the competent authority.
- 12. In case of any information, testimonial or any other documents found fake/bogus, the contract employee shall be responsible for it and FIR will be lodged against the defaulters.
- 13. In case of the above, the concerned DHO shall intimate such case to the Director General Health Services for legal action.

- 14. If any appointee found to be a Civil Servant, his/her contract shall be terminated immediately.
- 15. If he/she accepts the offer on the above mentioned terms and conditions, he/she is directed to submit arrival report to concerned District Health Officer within 03 days positively. In case of failure, the appointment shall automatically stand cancelled and next candidate shall be considered from the waiting list. Surety Bond of 100 rupees on the Judicial Stump Paper along with Medical Fitness Certificate must be submitted with the concerned DHO at the time of arrival on duty station.
